A motion was made by C.M. Milanowski and seconded by C.M. Henderson to approve the agenda. Motion passed unanimously.

A motion was made by C.M. McRoberts and seconded by C.M. Milanowski to approve the minutes. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Dodd to approve Blanket Voucher #202106 for Claim #'s 19852, 19854-19867 in the amount of \$45,216.60 and for Payroll # 19853 in the amount of \$1,000.00 for a Grand Total of \$46,216.60. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Milanowski to approve the purchase orders for: Up to \$500.00 for parts to repair the water line to 711 Main street (old Teriyaki stand), \$8714 plus tax for the pump to repair the 3<sup>rd</sup> St. Lift station with Paul picking it up, and Marine Industrial to inspect and clean the Reservoir and Clearwell at the Water Treatment plant for 2 days at \$2,750.00 per day. Motion passed unanimously.

Dodd to approve the Utility Bill adjustments for Acct #1569 refund of \$80.84 for Overpayment on Final Bill, Acct #1327 refund of \$10.23 for Overpayment on Final Bill, and Acct #1295 refund of \$4.49 for Overpayment on Final Bill. ### **PUBLIC HEARING**

Mayor Willey opened the Public Hearing regarding the Washington Street Variance application at 6:13 p.m.

Clerk/Treasurer Oster gave a brief overview of the application. The property owner is seeking a variance that would allow for the construction of 3 tri-plexes on 4 parcels that are currently zoned residential. The Town did not receive any comments in writing from property owners within a 300 ft radius. 2 phone calls were received with questions regarding the project, but those property owners had no objections

to the proposed structures. C.M. Dodd stated that the Planning Commission reviewed the application and gave their approval to send to council.

A motion was made by C.M. Henderson and seconded by C.M. Dodd to set a Special Meeting for March 23, 2021 at 6:00 p.m., this will give Council the opportunity to hear and ask questions of the 4 people who submitted letters of interest. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Dodd to enter into an agreement with Evergreen Rural Water to do smoke testing on the sewer system to locate areas that maybe allowing I&I into our system. Public notices will be sent out 2 weeks in advance prior to the testing in those locations. Motion passed unanimously.
