

Council Meeting
November 17, 2020

REMOTE MEETING- The regular council meeting was called to order at 6:00 p.m. by Mayor Willey. C.M. Dodd, C.M. Milanowski, C.M. Henderson, and C.M. McRoberts were present. Mayor Willey and Clerk/Treasurer Oster were present. C.M. Cox was absent. There was 1 citizen present.

A motion was made by C.M. Milanowski and seconded by C.M. McRoberts approve the agenda with the Lewis County Jail Bed Contract tabled until the next meeting. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by Dodd to approve the minutes from the Special Meeting on November 2, 2020 and the Regular Council Meeting on November 3, 2020. Motion passed unanimously.

A motion was made by C.M. Milanowski and seconded by C.M. Dodd to approve Blanket Voucher #202022 for Claim #'s 19678-19694 in the amount of \$27,625.67 and Payroll #'s 19677 in the amount of \$1,000.00 for a Grand Total of \$28,625.67. Motion passed unanimously.
