REMOTE MEETING- The regular council meeting was called to order at 6:00 p.m. by Mayor Willey. C.M. Cox, C.M. Dodd, C.M. Milanowski, and C.M. Henderson were present. Mayor Willey, Clerk/Treasurer Oster, Attorney Unzelman, and Water/Sewer Superintendent Petersen were present. There were 8 citizens present. Council seat #2 is vacant.
