

Council Meeting

December 1, 2020

6:00 p.m.

The Regular meeting was called to order at 6:00 p.m. by Mayor Willey. C.M. Dodd, C.M. Milanowski, C.M. McRoberts, C.M. Henderson, C.M. Cox, Mayor Willey, Clerk/Treasurer Oster, Water/Sewer Superintendent Petersen, and Attorney Unzelman were present. There were no citizens present.

A motion was made by C.M. Milanowski and seconded by C.M. Dodd to approve the agenda. Motion passed unanimously.

A motion was made by C.M. McRoberts and seconded by C.M. Milanowski to approve the minutes from the Regular meeting on 11-17-2020, Public Hearing- Property Tax Levy on 11-17-2020, Special Meeting- Executive Session on 11-23-2020, Public Hearing- 2021 Preliminary Budget on 11-24-2020, and The Special Meeting- Water Treatment Plant on 11-24-2020. Motion passed unanimously.

A motion was made by C.M. Milanowski and seconded by C.M. Henderson to approve Blanket Voucher #202023 for Claim #'s 19695 and 19706-19718 in the amount of \$25,654.87 and for Payroll #'s 19696-19705 in the amount of \$15,344.13 for a Grand Total of \$40,999.00. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Dodd to approve the purchase order up to \$1000.00 for evaluation and possible repair of a motor located at the WWTP by C&R Electric. The vote was 4 yays to 1 nay(Cox). Motion passed.

A motion was made by C.M. Milanowski and seconded by C.M. Henderson to approve the purchase order of \$1500.00 for an emergency repair of a water leak on First Street, which includes equipment, labor and fuel. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Cox to approve the Utility Bill adjustment for 1581.1 and issue a check to refund the overage amount that was paid. Council reviewed pictures of the leak and Paul Petersen was aware of the location. Motion passed unanimously. C.M. Dodd abstained from the vote.

**NEW BUSINESS**

A motion was made by C.M. Milanowski and seconded by C.M. Cox to approve the Senior/Low Income application for Acct# 1035. Motion passed unanimously.

A motion was made by C.M. Henderson and seconded by C.M. Milanowski to table the decision about the Oil Recycling container until the next meeting so they can have time to speak with their constituents. Motion passed unanimously.

C.M. Henderson asked for a motion from council to allow her to use free ad sites or locations to get rid of the last items from the Marshal's office that were surplusd in January. A motion was made by C.M. Cox and seconded by C.M. Dodd to allow C.M. Henderson to used free ad sites or locations to get rid of the last remaining non-operational items that were surplusd. Motion passed unanimously.

C.M. Cox thanked Clerk/Treasurer Oster for her work on the budget and the work she has been doing.
